Born in Oklahoma, Patrice Douglas is the fourth generation in her family to call Oklahoma "home." After graduating from Putnam City North High School, Patrice attended Oklahoma Christian University for her undergraduate degree, and the University of Oklahoma, where she obtained her law degree.

Patrice has served in executive positions, both in her family's large commercial construction company and in banking. She served as President of SpiritBank, and as Executive Vice President of First Fidelity Bank.

In April 2009, she was elected as Edmond's mayor and was unopposed for a second term. While serving as mayor, she championed public safety and led the effort to build a new public safety center, as well as creating the Small Business Task Force. She led the effort to partner with private and public entities to build Oklahoma's largest competition swimming pool complex. As mayor of Oklahoma's 6th largest city, she was elected and served on the Oklahoma Municipal League Board of Directors, and served on its Task Force on Government Efficiencies. She helped create the Mayors' Council on Economic Development and was elected as the Chairperson.

In 2011, Governor Mary Fallin appointed her to the Oklahoma Corporation Commission. She filed for election to this statewide position, and was unopposed for this term, which ended January, 2015. She was elected as Chairman of the OCC, effective August 1, 2012 and served as Chairman until she announced her candidacy for Congress, running to serve the 5th District of Oklahoma. As one of the few women to ever be a candidate for this position, she successfully made the run-off election. She has twice testified on behalf of Oklahoma before congressional subcommittees, testifying on behalf of cities and the oil and gas industry. She continues her efforts to educate on these issues with opinion editorials that appear across the nation.

After leaving public office, she returned to the practice of law, where she is "of counsel" for Spencer Fane Law Firm, representing clients who need legal advice in the regulatory and finance arena. She served on the board of directors of BankSNB, sitting on both the audit committee and the credit committee. Recently, she served on the Board of Directors of the public company, Midstates Petroleum as the Nominating and Governance Chairman, and later the Audit Chairman. In August, 2019, Midstates completed a merger with a similarly sized company, Amplify Energy. Patrice now serves on the Board of Directors for Amplify.

Community service is her passion. She has served on many different statewide boards, task forces, and non-profit organizations. She was the vice-chairman of Governor Keating's Task Force on Early Childhood Education. Serving two terms for the Edmond Economic Development Authority, she was elected chairman and served in that capacity 4 years. She also served on the Oklahoma Bankers Association Board of Directors, and the Executive Committee of the Edmond Chamber of Commerce. Currently, she is on the Board of Directors for the State Chamber of Oklahoma. She was a member of Leadership OKC, Class XIX, Leadership Oklahoma, Class XVII, and the 2012-2013 SALLT Leadership Class. She still volunteers for UR Special, an organization founded by her mother, to serve at-risk children in Edmond.

Patrice received the Kate Barnard Award for Outstanding Public Service in Oklahoma— the first municipal official to receive this honor. She is a three-time finalist for the Journal Record's Woman of the Year, and has been named Oklahoma Christian's Distinguished Alumni for the College of Business. Patrice was also the recipient of the Energy Visionary Policy Leadership Award in October 2013.

Family and faith are her focus. Her husband of 32 years, Brent Douglas, is president of Magellan Executive Partners. Her two sons, Patrick and Phillip, are the lights of her life.
