Jane Haskin was born and raised in the Oklahoma oil boom town of Drumright. Jane took advantage of the many opportunities living in a small town provided for teenagers to work during summer breaks and after school. She worked at the movie theater, office supply store, print shop, and high school. These jobs taught her the values of hard work and providing good customer service. After graduating from Drumright High School, Jane attended the University of Central Oklahoma in Edmond, receiving a degree in Accounting and passing the CPA examination.

Jane began her banking career at Union Bank, becoming a commercial loan officer and Senior Vice President. She later worked at Local Oklahoma Bank in the same capacity. During her banking career, she served as the first woman to Chair the Board of Directors of the Oklahoma Bankers Association and has also served as Chair of the Board of Directors of the Oklahoma Society of CPAs. In 2014, the American Banker Magazine recognized Jane as one of the 25 most powerful women in banking. In addition, she served on the Board of Directors of the Oklahoma City Branch of the Federal Reserve and the FDIC's Advisory Committee on Community Banking in Washington, D.C. She also was a member of the ABA's Community Bankers Council and authored book reviews for the *ABA Banking Journal*. In addition, she was the Board Chair of the University of Central Oklahoma Alumni Association, The Northwest Oklahoma City Chamber of Commerce, and Junior Achievement of Oklahoma City. Her final position before retirement was over eleven years as the President and CEO of First Bethany Bank. She retired in June of 2017 after 39 years in the banking industry; however, she continues to serve on the Board of Directors of First Bethany Bank. In 2019, Jane was inducted into the Oklahoma Society of CPA's Hall of Fame.

Teaching financial literacy has always been a passion of Jane's, and she taught Junior Achievement in area schools for over thirty years. She believes that lessons in personal finance should be an integral part of EVERY student's education. Junior Achievement USA awarded her the Gold Service Medal for her work. Jane has been honored to serve on several non-profit boards.

Currently, Jane serves as a Trustee for the Oklahoma Student Loan Authority, Trustee for the Sunbeam Family Foundation, Board member for MetaFund, and First Bethany Bank. Jane is married to her high school sweetheart Michael Haskin. She is the proud mother of one daughter, Sarah, a CPA in Salt Lake City.
